## IN RECOGNITION OF ALLISON AND ALAN KELLMAN



- Whereas,* A GREAT STATE IS ONLY AS GREAT AS THOSE INDIVIDUALS AND THEIR ORGANIZATIONS WHO PERFORM EXEMPLARY SERVICE ON BEHALF OF THEIR COMMUNITY, AND IT IS THE CUSTOM OF THIS GREAT STATE TO PAY TRIBUTE TO THAT OUTSTANDING SERVICE; AND
- Whereas,* ATTENDANT TO SUCH CONCERN, **I, STATE SENATOR AND SENATE MAJORITY LEADER, ANDREA STEWART-COUSINS**, AM JUSTLY PROUD TO HONOR **ALLISON AND ALAN KELLMAN** UPON THE OCCASION OF *BETH EL SYNAGOGUE CENTER'S "A NIGHT UNDER THE STARS"*; AND

- Whereas,* **ALAN** ATTENDED THE HEBREW ACADEMY OF NASSAU COUNTY IN HIGH SCHOOL; HE GRADUATED FROM THE UNIVERSITY OF PENNSYLVANIA'S SCHOOL OF ENGINEERING, AND EARNED HIS LAW DEGREE FROM HARVARD LAW SCHOOL; **ALAN** LATER BECAME A FOUNDING PARTNER OF THE PATENT TRIAL FIRM, DESMARAIS LLP.
